GOLF EVENT AGREEMENT

THIS AGREEMENT, effective the _____ day of _____, 20____, between

(hereinafter referred to as the "Guest") and BAKKER CROSSING GOLF COURSE, 47172 Clubhouse Rd., Sioux Falls, SD 57108 (hereinafter referred to as the "Golf Course").

WHEREAS, the Guest desires to reserve and use the facilities of the Golf Course for a golf Event scheduled for the _____ day of _____, 20___. A non refundable security deposit of \$ 250 will be required to reserve the date of the above said Event. After your event the deposit will be deducted from the final bill

1. **GOLF:**

A. The event will take place at _____ o'clock am/pm on the date referred to above with the following format: Shotgun / T-Times.

B. The Guest agrees to have a minimum of 100 players for a shotgun start on the weekend and 72 players for a weekday shotgun start. Every player MUST take a cart if a shotgun start is selected in 1B

C. The Guest needs to notify the golf course seven (7) days before the Event the number of players that are playing in order to secure any extra golf carts that are needed or open any t-times that might have been reserved. In the event that extra golf carts are needed there will be an additional \$7.00 charge per golf cart that needs to be rented.

D. The total per person charge for the golf portion of the Event shall be \$ _____, which will include (circle those that apply) Green Fees Cart Fees Prizes Other _____.

E. It is understood by the Guest that Bakker Crossing Golf Course requires the use of alternative spikes for play on the course.

F. It will be the responsibility of the Guest to contact the Golf Course Professional, Jason Sudenga at (605) 368-9700, to arrange for the event scoring format, any contest prior to or during the Event, and such course markings as are needed.

2. **FOOD & BEVERAGE:**

A. Food may be provided by the Guest or the Golf Course. All food and any catering must be approved by the Golf Course. If the Guest decides to bring in food there will be a \$250 rental fee for the use of the clubhouse. If the Guest decides to have a catered meal then the rental fee will be waived. Prices and menu will be attached as Exhibit "A".

B. ALL beverages must be purchased from the Golf Course. No outside coolers or alcoholic beverages are allowed.

C. The Beverage Cart will be made available on the golf course to sell normally stocked items during the golf portion of the Event. Only employees of Bakker Crossing Golf Course will be permitted to operate the Beverage Cart and dispense beverages. Any items purchased from the beverage will be at normal golf course prices.

3. **RIGHT OF CANCELLATION.**

A. The Golf Course shall have the right to cancel the Event, without notice, when, in the sole discretion of the golf course, the weather or golf course conditions make the course unplayable. In the event of the Golf Course canceling the Event, the Guest and Golf Course will make a reasonable effort to reschedule. If no date can be set the agreement will be terminated. The Golf Course is not responsible for any monies that the Guest has spent toward the Event scheduled.

4. **RESPONSIBILITIES OF GUEST**

A. The Guest shall be responsible to the Golf Course for any damages done to the property of the Golf Course by any representative of the Guest or anyone participating in the Event. The Golf Course reserves the right to remove from its premises at any time any person who fails to obey the Golf Course rules, dress code, damages property, becomes intoxicated or in the opinion of the Golf Course, fails to conduct himself or herself appropriately.

5. **CONTACTS:** The person representing the Guest with whom the Golf Course can communicate to coordinate the Event and who shall be responsible to the Golf Course is:
